Missing Man Table & Honors Ceremony

Those of us fortunate enough to attend the Stated Meeting in November were rewarded with a memorable and inspiring salute to veteran's program. The Colorado Mormon Chorale performed, Rick Jasper, 32° KCCH, orated the *Missing Man* ceremony, and our Consistory Flag Drill Team executed the *Flag Ceremony* in concert with the ceremony. Alex McIntosh, 32° KCCH played the bagpipes at the conclusion of the ceremony.

Everyone present at the presentation left feeling uplifted and touched by such inspiring entertainment. The songs were performed with dignity and musical excellence. The ceremonies were reverent and respectful. Many hope to see programs of this nature again in the future.

For those of you not in attendance, the ceremony text is presented below to provide our readers with an indication of the program. Mere words cannot do justice to the program, but the respect, vigilance, dedication and reverence toward our veterans is evident. Please spend a few minutes absorbing the ceremony text describing the table. The heart of the ceremony is presented there.

The ceremony text

Good Evening,

I would like to call your attention to the spot lighted table and explain its purpose.

It is reserved to honor our missing loved ones, our missing comrades in arms, our veterans from



WW II, Korea, Viet Nam, Desert Storm, Iraqi Freedom or as this war is being called the War on tourism.

The empty place represents Americans, our men and women still missing from each of the five services -- Army, Navy, Marine Corps, Army Air corps / Air Force, Coast Guard. The civilians, Police and Fire. This Honors Ceremony symbolizes that they are with us, here in spirit.

Some of you in room this evening may have been very young when you were sent into combat; however, all Americans should never forget the brave men and women who answered our nation's call to serve; and served the cause of freedom in a very special way.

I would ask you to stand, if you are able, and remain standing for a moment of silent prayer.

Moderator:

Amen, please be seated ... I would like to explain the meaning of the items on this special table.

The table is round -- to show our everlasting concern for our missing men and women.

The tablecloth is white -- symbolizing the purity of their motives when answering the call to duty.

The single red rose, displayed in a vase, reminds us of the life of each of the missing, and their loved ones and friends of these Americans who keep the faith, awaiting answers.

The vase is tied with a red ribbon, symbol of our continued determination to account for our missing.

A slice of lemon on the bread plate is to remind us of the bitter fate of those captured and missing in a foreign land.

A pinch of salt symbolizes the tears endured by those missing and their families who seek answers.

The glass is inverted -- to symbolize their inability to share this evening's toast.

The chair is empty -- they are not here!

I offer one last thought in tribute to our veterans. Country western songwriter and performer sums their contribution up best when he sings "All gave



some, Some gave all!"

In other Masonic groups, he was Master of Denver Lodge No 5 in 1973, Grand Master of Masons of Colorado during 2003, a Past High Priest in Royal Arch Masons during 1999-2000 and a Past Commander with the Knights Templar in 2003-2004. He is presently an officer in Red Cross of Constantine, President of the Masonic Temple Association of Denver, Treasurer of both his Lodge and Royal Arch Chapter and a member of El Jebel Shrine since 1973. He is active and committed to the Masonic fraternity as both a leader and follower.

An eastern Colorado native, Claud lives with his wife Karen in Englewood. They have two adult daughters and two grandchildren. He enjoys gardening with his grandchildren, family activities with his and Karen's large extended family and attending Denver Bronco games.

A SOLDIER HAS FALLEN, HIS LEGACY CONTINUES

On Monday, November 10, 2008 a very special display of honor, gratitude and love was presented to our departed comrade and brother, Darrell Lynn Tygart, Sr. A standing room only assemblage in the Tri-City Baptist Church was present to say goodbye and to show respect



for a great man and mason who has done so much to further the spread of brotherly love and fellowship by his service in the United States Marine Corps, the Westminster Police Department and Freemasonry at all levels. This service was immediately followed by another capacity crowd at the El Jebel Shrine Auditorium allowing all to show love and support for Darrell's true love, his beloved wife, Angel and their family.

As a third generation Colorado native, Darrell was born in Denver May 10, 1948 and completed his journey here on earth as a resident of Westminster, Colorado. As an active member and recruiter of the Craft, he was proud that his son Darrell, Jr., his brother Steven and nephew James are all members of Liberty Lodge #134 in Denver.

Darrell proudly served his country in the United States Marine Corps from August 16, 1965 to September 15, 1974 and never let us forget that there is no such thing as an "ex-marine." As an E6, Staff Sergeant, he was a Helicopter Mechanic and Crew Chief of UH34D AND CH46D helicopters and saw combat service in Vietnam. Of his many military decorations he had received: Combat Aircrew Wings with three Stars, Navy and Marine Corps Medal for Heroism, Vietnamese Cross of Gallantry with Palm, Air Medal (36 Awards), Purple Heart Medal, Presidential Unit Citation with one Star, Meritorious Unit Citation, Navy Unit Commendation, Good Conduct Medal (three Awards), National Defense Medal, Vietnamese Meritorious Unit Citation, and the Republic of Vietnam Campaign Medal.

But our dear friend was not finished with his service to mankind. He entered into a career in Law Enforcement in September of 1973 as a reserve police officer for the Millington Tennessee Police Department and then into the Westminster Colorado Police Department in February of 1975, starting as a Patrolman and after serving in every department of the WPD, retired as Commander in April, of 2006. Of his many noteworthy awards

were: 1986 Adams County Bar Association's Police Officer of the Year, 1988 Westminster Police Protective Association Peace Officer of the Year/ Excellence in Law Enforcement Award, 1988 City of Westminster's Excellence in Action Award, 1990 Adams County Victim Advocates Coalition Outstanding Investigations Commander Award, 1995 WPD's Distinguished Service Medal for his singlehanded apprehension arrest of an armed bank robbery suspect who was fleeing from a local bank, and in 1995 Recognized by the F.B.I. for the successful arrest and prosecution of the bank robber (noted above). He was a member Past President of the and Fraternal Order of Police/ Westminster Police Protective Association. He was a member of the Colorado Police Protective Association, the Metro Denver Robbery Intelligence Group, the

National Association of Police Field Training Officers, National Association of Police School Resource Officers, and the Colorado Association of Police School Resource Officers.

Darrell began his journey in Freemasonry as an Entered Apprentice on January 7, 1972 in the Summer Avenue Lodge #729, F. & A.M., Memphis, Tennessee. He was passed to a Fellowcraft, February 14, 1972 and Raised to a Master Mason March 17, 1972 in the same Lodge. In 1983, he demitted to Edgewater Lodge #159 A.F. & A.M. which subsequently merged with Liberty Lodge #134, A.F. & A.M. and served as Worshipful Master in 1991 and 2003. Darrell was named the Mason of the Year in 1992 and served as the Grand Orator of the W.M. Grand Lodge of Colorado in 1999. He was a dual member in South Denver Lodge #93, A.F. & A.M.

In 1986, Darrell joined the Golden Chapter #5, Royal Arch Masons; Jefferson Council #24, Cryptic Masons; Jefferson-Highlands Commandery #30,

Knights Templar and served as Eminent Commander in 1988-1989. He was a plural member with St. Bernard Commandery #41 and he served as the Right Eminent Grand Commander of the Grand Commandery of Knights Templar of Colorado 2000-2001.

In the Ancient and Accepted Scottish Rite of Freemasonry, he was consecrated a 32^{0,} Master of the Royal Secret, June 3, 1972 in the Valley of Memphis, Orient of Tennessee and demitted to Rocky Mountain Consistory in 1983. He was Invested with Knight Commander of the Court of Honor in 1993 and Coroneted with 33⁰, Inspector General Honorary in 1997. Darrell was Wise Master of Rocky Mountain Chapter of Rose Croix in 1997, a member of the Rose Croix Funeral Team and worked in the ritual of many degrees. He was appointed Director General of the

Denver Consistory Degree Council in 2001 and was appointed and served as Executive Secretary of the Denver Consistory from 2006 - 2008. As such, he oversaw building modifications to the Scottish Rite Masonic Center at 1370 Grant Street in Denver and many structural conversions and improvements throughout the building. He led in the training and development of masonic education and membership and the team building now in place. Darrell's favorite expression was that he was "living the dream." As Director General, he planned and conducted the first Reunion implementing the revised Pike Degrees when all 29 degrees were exemplified involving the work of more than 600 Scottish Rite Masons - the first time all 29 of the revised Pike Degrees were performed in the Southern Jurisdiction. Continuing this, he planned and conducted Reunions exemplifying all 29 degrees at four Reunions between May 2002 and May 2006. He played a major role in conducting Reunions in Sterling in 2004 and Breckenridge in 2005, the latter being a joint reunion of the three Colorado Valleys. As Secretary, he oversaw the application and completion of a 501(c)(3) for a building operational endowment fund. He helped conduct the Scottish Rite Regional Reunion in 2007. He acquired the collection of framed artwork depicting the apron and jewel for all the degrees which is now on display in the Activities Room. He led the development of the Activities Room and Symbolic Lodge room and the fenced-in garden area. He was successful in obtaining a long-term lease of the second floor of the Consistory office building. Darrell did what he was so very good at training and delegating an efficient office staff.

Shrinedom found Darrell to be a leader as well. He was created a Noble in Al Chymia Shrine, Memphis, Tennessee in 1972 and demitted to El Jebel Shrine in 1986. He became Captain and President of the Motorcycle Patrol and was President of the Jeep Patrol. He was a member of the Royal Order of Jesters and served El Jebel as a Potentate's Aide. From 1999 through 2001, Darrell served as Chaplain for the Divan of El Jebel and in 2005 was appointed as 2nd Ceremonial Master and was elected as High Priest and Prophet of El Jebel in 2008.

Darrell shared with us his goal of working hard and enjoying life and to give more back than one takes. He wanted to leave the world around him better than when he found it and he succeeded. Throughout his life, those he touched have benefitted. Darrell is now at peace and at home in that "House not made with hands" and he has left us with the message to continue his legacy of growth in masonry and the brotherly love, relief and especially truth he lived to the fullest. We all now must echo his lesson of "Living The Dream".

The **JAWBONES** do all the talking, but very little else.


The **KNUCKLEBONES** sit back and knock everything.

Did You Know? – Cerebral Palsy of Colorado has a Unique Relationship with Scottish Rite and the Shrine

On November 25, 2008, I spent the day visiting with Judy Ham, the President and CEO of Cerebral Palsy of Colorado (CP) at the CP center located at Lowry in Aurora. I also had the pleasure of visiting with Ms. Heather Hyatt-Montoya, a devoted mother of a child with infantile scoliosis, who founded the Infantile Scoliosis Outreach Program, a service provided by CP.

The Cerebral Palsy Association (the predecessor to CP) was incorporated in 1952 with roots beginning in 1946 when a group of nine Founding Mothers met in a waiting room at The Children's Hospital and discussed possible opportunities outside the then-traditional institutionalization of children with Cerebral Palsy. As a result, the first school in Colorado for children with disabilities was opened in 1953 by the Cerebral Palsy Association.

CP has evolved from it early years as the provider of a school for children and youth with disabilities to a provider of services focused on comprehensive educational, employment, and family support. Serving individuals with disabilities, at-risk children, and children in the general population, CP's programs are designed to effectively educate and help children in an integrated and diverse environment. Including CP's many programs, it serves more than 20,000 children, youth, and adults with disabilities and their families each year.

I walked away from my visit with some distinct impressions of the amazing work being done by CP of Colorado. This work involves:

1. Our Scottish Rite and Shrine hospitals,

2. Speech therapy and early language and literacy programs, and

3. An Aurora charter school – Vanguard Classical School – founded by CP.

Our Hospitals....CP provides an outreach service to families of children with a debilitating condition, known as infantile scoliosis. This condition is a painful deformity of the spine for which premature invasive surgical techniques have been and continue to be used by most orthopedic surgeons. This invasive treatment is painful and frequently leads to death.

CP of Colorado, through its Infantile Scoliosis Outreach Program (ISOP), is responsible for educating parents and orthopedic surgeons in the U.S. regarding a highly successful non-invasive Early Treatment Process. ISOP collaborates with medical institutions, most importantly with the orthopedic hospitals in the Shrine and Scottish Rite, in educating medical professionals in the Early Treatment Process by applying casts on young children to train their spines to grow straight.

This non-invasive early treatment was developed several years ago in the UK by Dr. Min H. Mehta, an orthopedic surgeon, now in retirement and consulting with orthopedic hospitals in the U.S. regarding this treatment. Most recently, in October 2008 Dr. Mehta presented at an infantile scoliosis conference at the Texas Scottish Rite Hospital for Children in Dallas.

The bottom line of significance to us is that orthopedic surgeons at the Texas Scottish Rite Hospital for Children and the Salt Lake City Intermountain Shrine Hospital (as well as several other Shrine hospitals) are now using Dr. Mehta's innovative and non-invasive process to successfully correct this deformity, enabling effected children to lead lives without a painful spinal deformity.

Speech Therapy....CP, through its Creative Options for Early Education Program, is serving hundreds of children (734 last year) and their families by providing early childcare, education, intervention and family support. A speech therapist and an audiologist are on CP's permanent staff and

all children are screened within 45 days of enrollment with appropriate referrals being made when necessary. The majority of children enrolled in Creative Options qualify for Head Start or Early Head Start programs, which means their families are living below the federal poverty line. Early language and literacy training is an important component of the program, and I had the pleasure of observing some classes of young children working on language and literacy skills led by CP's trained and expert professionals. In addition, the program has a grant-funded amplification system to help children with auditory or language challenges better understand classroom instructions and activities.

An Aurora Charter School.....Known as Vanguard Classical School, CP founded this K-7 school (expanding to K-8 in the 2009-2010 school year) as an innovative charter school in the Aurora Public School system. With 434 students, each classroom has two teachers, one being a special education teacher, and with a student/teacher ratio typically at 15:1. Students wear a uniform and learn in a discipline-rich and interactive environment where children with and without disabilities receive expert attention and instruction. As I toured this school visiting the various classroom environments, I observed excellent student engagement in their activities and with their teachers. And, as a formerly certified high school teacher (although I never entered the profession), I was very impressed with the school's emphasis on language and math programs.

In Summary.....Much more could be said about CP of Colorado, which I am delighted to have received such a welcoming introduction. It gives us one more reason to be proud of the work Scottish Rite and the Shrine are doing to make a difference in the lives of children in Colorado and throughout the United States.
