PRO/CON

EVERYONE is encouraged to think about the questions, but more importantly, submit a short (SHORT) essay taking either the YES/PRO side OR the NO/CON side. We ask that you try to keep your responses to a minimum of 250 words, but no more than 500. This should be an interesting exercise for everyone, and perhaps we'll all benefit and learn something new in the process.

In last month's RiteWorks, we asked the following question:

Are we asking our newly-made Masons to Join Appendant/Concordant Bodies too soon after they pass their Proficiency?

MWB Charles G. Johnson, 33° took the "No" side, and Brother Lance Rommerdahl, 32° took the "Yes" side.

Join us now, as we explore BOTH sides of this question and think about these perspectives as they might pertain to you. First up: MWB Johnson's exposition, followed by Bro. Rommerdahl's.

Are we asking our newly-made Masons to join appendant/concordant bodies too soon after they pass their proficiency? **NOT AT ALL, MY BROTHERS!** These new Brethren are eager for Masonic knowledge and if we hold them back until we think they are ready, we may well be doing a great disservice to them.

Men who have discovered the light of Masonry have an insatiable thirst for more and it is lame at best to 'coach' them compared to others we have posted. Men today are much more informed and very well versed in technology. They will find answers to their questions and the answers they obtain may contain lots of incorrect information. Why not use their desire for more Masonry to guide us in directing them toward other sources and provide them with a total experience?

The old adage about 'drinking from the fire hose' certainly applies here, but with proper guidance and mentoring we can assist each new Brother with help to 'digest' what he has learned. Participation and involvement goes a long way with new Brethren in filling the gaps,

and we absolutely need to make sure they become active after the degree work and help present it to others.

We have all experienced viewing a movie for the second time and discovering things that slipped by us on the first viewing. This is certainly true in degree work, so by moving them along to join other Masonic Bodies and urging their participation in their presentations, these newly-made Brethren can attain the knowledge they are seeking. In maintaining standards, we all know that sometimes 'less is more.' No doubt, the standards of quality in Masonry must be supported, but sometimes maybe 'more is more.' It really depends on the individual Mason, and in the end it also depends on all of us to provide Masonic knowledge and great experiences to our Brethren.

AND NOW ... Brother Rommerdahl, with his take on the question.

Freemasonry is an initiatory process. It is not a sprint, but a marathon. Three-hundred years ago, at the forming of the Grand Lodge of England, a Mason had to wait three years before he could receive a higher degree. Now there are one-day events. Our ancient Brethren recognized the newly-made Brother had to wait. Unfortunately, in the quest for more membership, to make things easier and as a requirement to assist other organizations, this was set aside; done for all the wrong reasons.

There are numerous lessons to be learned from the three degrees. The degrees merely touched upon these lessons. They were just an introduction. And, in my opinion, these lessons are more relevant to Freemasonry. Most Grand Lodges have extensive lesson plans explaining the symbols and lessons in the three degrees. The lesson plan that I took was almost a year long. It greatly increased my appreciation of the craft and the degrees. Lessons can be learned in the Blue Lodge if they have the appropriate Masonic education that will greatly increase the new initiate's knowledge of Masonry. There is plenty in this quarry of the Blue Lodge to satisfy any need to learn more about Masonic philosophy and increase his appreciation of our gentle Craft.

Another reason is that the appendant bodies have been called, and can be, a distraction to some extent. This was ably explained in the book "Observing the Craft" by Andrew Hammer. The new initiate needs to take a break and get his bearings, Masonically speaking, in the Blue Lodge. He needs to age in Masonry so that he can appreciate what has happened to him. A waiting period is needed so that he can take stock before moving onto other ventures. He doesn't need to be pressed or rushed.

Some Blue Lodges need the help of new blood entering our gentle Craft. Officers' chairs are retreaded or not filled because Brethren are drawn to appendant bodies. The lure of the proper recognition of a colored hat, an apron of distinction, a lifelong title, all draw Brethren away from not only the needs of the Blue Lodge, but the personal growth of the individual in the different chairs and tasks needed to be completed in his Blue Lodge.

NEXT QUESTION: Is it wrong to become a Mason ONLY to join another masonic group?

I've noticed a disturbing trend in social media - moreso of late than before because we're entering what I like to call "silly season" where politics takes over the airwaves and we are inundated with ads and editorials. But, social media allows us and our friends to take that proverbial soapbox to another level entirely.

It's a pretty sad commentary on our times and societies that we find all-too-often the need to label someone a democrat, republican, conservative, liberal, anti-this, pro-that, along with an abusive or invective adjective as though that is the only characteristic worth mentioning about them. And, what is worse, we tend to disregard ANYTHING being said (regardless of whether it might be true or not) from the "other side" (not our side). More often than not, "truth" is somewhere in the middle of the two extremes in an argument.

We have somehow deteriorated into a less-than-civil society where name-calling, flame-baiting, and just plain old nastiness is considered the norm and is not only acceptable, but is almost expected to establish our bona-fides in the clique of our choice.

Gone seem to be the days of compromise, of civil conversations, and of respectful disagreements. Binary litmus tests on just about any topic (meaning, yes/no with no middle ground acceptable) seem to be the rule instead of the exception.

You can see this in our congress: regardless of which party is in control, they just can't seem to get much done - "legislative constipation" I'll call it.




Toini Morgan received her undergraduate degree in English with a minor in print journalism at the College of St. Catherine. After a decade in the workforce, she discovered her passion of working with children and teens through doing volunteer work at The Conflict Center and the First Unitarian Society of Denver and decided to pursue a career in speech-language pathology.

Tammi S. Harnan - University of Northern Colorado

Tammi Harnan is a Colorado native and received a bachelor's degree in psychology from the University of Colorado and a bachelor's degree in speech and hearing science from the University of Washington.

Prior to pursuing speech-language pathology, she was a child protection case-worker and repeatedly observed the impact of circumstances and lack of services on young children's language.

Tammi cites an example of a four-year-old boy, who did not have language skills, throw his shoes and run around the room demonstrating the violence he witnessed. She said he could not understand my specific questions or effectively communicate. She said, "He looked straight into my eyes, as if saying 'Now do you get it? Please get it.'" Tammi is committed to strengthening communication for underprivileged and underserved children in Colorado.



Becca Ruske - University of Northern Colorado

Becca Ruske was raised in a rural mountain town – Grand Lake, Colorado – where the close-knit community and small town became a part of who she was. Following her undergraduate degree, she traveled to South America, where the strong culture and Spanish-speaking natives inspired her to take a closer look at the unique human interaction that is communication.

Following graduation, Becca hopes to work in her rural hometown by serving children, empowering parents, providing resources, and being a present and consistent presence in the community.

Becca says of children, "Their youth, innocence, and unsurmountable joy draw me into their world where everything is novel and beautiful. Working with children lets me come alive and I often learn more from them than I set out to teach them." Of the Masonic Fraternity she states, "I appreciate all that you do and am thrilled to have so many close family members (and my fiancé Jonas) support this amazing organization."

Reuben Job has written a small book which has become quite popular. The book is titled "Three Simple Rules for Living." I feel these rules apply to us as Masons.

The first rule is "Do No Harm." To do no harm means that I will be on my guard so that all my actions and even my silence will not harm any Mason, nor will any of my actions bring harm to our fraternity. This does not mean that if we see a fellow Brother doing something wrong we should not call him on it. For example, I have called brothers on their use of the "F" word, or the "GD" words. We need to hold each other accountable.

The second rule is "Always Do Good." I know it SOUNDS easy, but it is not. St. Augustine wrote, "You owe your conscience to God; to one another you owe nothing but mutual love." In doing so, we must never forget ourselves. The Bible teaches us to love our neighbor as we love ourselves. In our Scottish Rite, I am always amazed by the good way we treat each other. These first two rules will help with membership growth and retention. In Acts, the early church grew because people saw the way church members were treating each other. They were loving, sharing, and caring.

The third rule is "Stay in Love With God" (The Supreme Architect). In the Old Testament, God punished the people and individuals when they strayed from Him. I am much happier and at peace when I follow these three rules.
