Freemasonry is Universal?

Well, hold on just a moment before we climb on board that train. If you want to see how the Mother Grand Lodge (United Grand Lodge of England) does things, hiaku over to Netflix and look up “Inside the Freemasons” - a five part series about the 300th celebration of the founding of the UGLE. Now, to be fair, you’ll see a lot of pomp and circumstance, a lot of ornate buildings (all of which appear to be in fine condition, by the way), the beautiful and impressive Grand Lodge building, and the rather ornate aprons associated with Grand Officers, as well as lodge officers. Yes, this is EUROPE—and they do things differently over there. But stay with the program and you’ll find that they have come up with (what they call) a “scheme” to attract younger men (under 30) into Masonry and it appears to be working. They target that group of university men as well as forming specialty lodges (including a “football lodge” - soccer to us - where the gavels are actually football shoes made of wood and there are a number of other unique things about that new lodge (#9921 on the rolls) see: <https://www.facebook.com/FootballLodge/>

But, more importantly, they focus on younger men by offering a “reduced” cost associated with membership. Remember, over there, a pound is about \$1.25 and they do not make as much money for a given profession as we do here. This “reduced” set of fees is covered in the 5th and last installment of the series: £215/year “subscription fee” (membership) and typically £24 for dinner, add another £5-6 if you want wine. And, while their university system is completely different from ours, students over there are just as concerned with their finances as we are.

Other aspects are the cost of their regalia - it will take your breath away. My £35 (\$70 at the time) rather ornate MM apron from my lodge today would run me about £450, and if I was in any other body (Royal Arch, Cryptic Council, KT, KM, etc) each of them would have similar aprons unique to that body.

Just the cost of belonging to a lodge over there is NOT the only difference. Ritual is completely different, my obligation is totally different from yours. AND ... you don’t really have to look overseas to see differences in Masonry - you only have to cross a state line and sit in a lodge to find that ... as I like to say ... there is enough similar to make me feel like I’m not out of place, but there is enough different to make me sit up and take notice.

UNIVERSAL? Hardly. But, that’s part of the wonder of Freemasonry—that we can travel in foreign lands and still be welcomed and feel comfortable in the midst of our Brothers. IT’S an EYE-OPENING series ... be sure to watch it all.

RiteCare Colorado News "The Genesis of Colorado RiteCare"

With this article we are beginning a series about the work of RiteCare Colorado, the tag name for the Scottish Rite Foundation of Colorado (SRF). This foundation is a 501(c)(3) tax exempt non-profit organization incorporated in 1953 in accordance with the laws of the state of Colorado.

SRF is one of the first organizations in the United States to financially assist families seeking speech therapy for preschool-age children. And most notably, it is the first such organization in the Scottish Rite Masonic Fraternity to do so. Today, Scottish Rite Masons in all 50 states support one or more aspects of work addressing childhood speech and language disorders through separate non-profit Masonic organizations.

SRF was organized five years after Children's Hospital in Denver opened a speech pathology clinic in 1948. In 1952, William G. Schweigert, 33°, the Almoner of Rocky Mountain Consistory in Denver, was contacted by a social worker at Children's Hospital. He was presented with the case of a widowed mother not being able to afford speech therapy for her young child. Her little boy could only utter unintelligible sounds. Wil began helping with the Almoner's fund while at the same time presenting the issue to the Sovereign Grand Inspector General for the Orient of Colorado, Haslett P. Burke, 33°, and the Almoner of Colorado Consistory in Denver, Gerald L. Schlessman, 33°.

After much study and discussion, the Orient of Colorado created the Scottish Rite Foundation of Colorado in February 1953. Sixty-five years later, we're still answering the call. Through 2017 we have served more than 20,400 children, spending more than \$40 million in making such care possible.

We currently support speech and learning therapies throughout Colorado by partnering with nine organizations. Seven of them provide speech pathology services and three provide early language and learning services. One of the three also provides speech pathology services.

Professional therapy and early language care is now available statewide with facilities in 16 communities. In addition, our lead partner, Children's Hospital Colorado, enables statewide coverage through telepractice, an internet-based platform for delivering speech therapy services to locations distant from clinic facilities.

From 1953 through 1985, we worked with one organization in just one location, Children's Hospital near downtown Denver. Seeking to serve children throughout the state, in 1986 we began to expand our speech pathology provider network. We now partner with four hospitals (clinic locations in Aurora, Broomfield, Highlands Ranch, Parker, Colorado Springs, Pueblo, Grand Junction, Montrose, and Gunnison), two universities (clinic locations in Boulder and Greeley), one non-profit speech therapy provider (clinic locations in Fort Collins and Loveland), and two early language programs (locations in Cortez, Dolores, Towaoc, and Grand Junction).

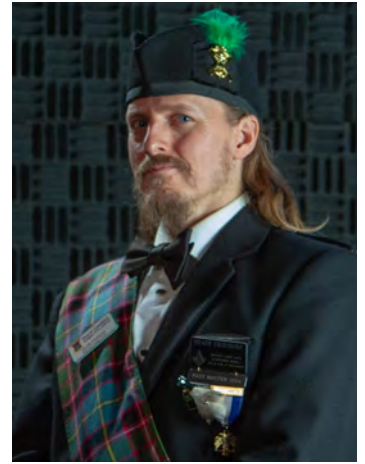

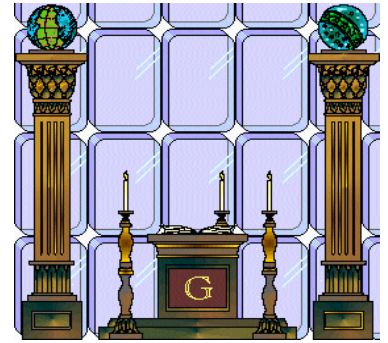

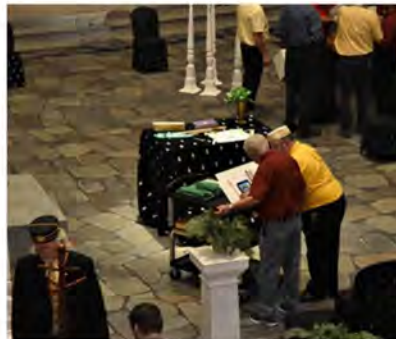
