By now, most of you have probably noticed that I haven't been quite as "visible" around the Consistory of late. Well, there's really a simple explanation for that. I have been struggling with FOUR—count 'em—FOUR kidney stones. Two in each kidney. All in the 6-8 mm by 8-10 mm size—TRANSLATION: BIG ROCKS!

Back in around 1985, I woke up in the middle of the night before my wife and I were supposed to leave for a birthday trip with our daughter Jo to Disney World. I was screaming in agony, writhing on the floor trying to find any position that might offer the slightest bit of comfort. My wife called our doctor and asked what she should do. The doctor told my wife that I probably wasn't dying because I was able to scream so loudly, and we should go to the emergency room. She took me to Bethesda Naval Hospital where the ER doc immediately told me I was having a kidney stone and gave me a shot of morphine. As the morphine waved over my body, the pain just disappeared and I felt a lot better. I did make a mistake—two of them in fact. The doc asked if I could still feel the stone. I could, but there wasn't any significant pain, but he said he didn't want me to feel ANYTHING, so a 2nd shot was given. He comes back a few minutes later and I still haven't learned my lesson, I tell him it's a little like a love-pinch and nothing to worry about—a third shot. I finally learned, but now I had to remain in the hospital because of the danger of respiratory arrest. We missed our trip to Disney World. We later made it up to my daughter, but it just wasn't the same as a birthday trip.

A nurse in the ER told me that she had had a baby and she'd had kidney stones, and on the whole she would rather have a baby because she knew the pain would be over "soon." With kidney stones, you never know how long the pain will last because that stone is a lot bigger than the ureter that it's trying to move through (very slowly). In fact, she later said, "about the only way I can describe the pain of a kidney stone is that it's ALMOST like giving birth to a set of broken dishes." I told her I would just have to believe her on that description.

So, the stones are still there, and for the time being sitting quietly. I'm set for a procedure to address at least one, maybe more of the stones on 07April, with follow-up recovery later the next week. So, I'll see you when I see you, based on really good medication and whether or not I'm feeling OK. It'll be over eventually—I just don't know when.



A Point of Pride Revisited, Part 2

Last month, we began a look at the fourteen Masons who have served the nation as President, beginning with a very quick glance at our "top three" and "bottom three," as rated by a Survey of Presidential Greatness, begun by Prof. Arthur Schlesinger, Sr. in 1948. We'll continue that overview, this month, and then delve a bit into issues of individual character and their Masonic careers.

You'll recall that the fourteen Masonic presidents rank this way, in that survey:

2. George Washington

4. Theodore Roosevelt

- 14. William McKinley
- 28. Gerald R. Ford

- 3. Franklin D. Roosevelt
- 18. James K. Polk 22. Andrew Jackson

- 37. Warren G. Harding
 - 43. Andrew Johnson
 - 44. James Buchanan

- 6. Harry S. Truman 12. James Monroe
- 23. William Howard Taft 27. James A. Garfield

Last month, we made our way through the top and the bottom pair, with a few comments about their records in office, and made a few observations also about Teddy Roosevelt and Warren Harding. So, we'll begin this second round with another pair, again picked one from the high and one from the low end of the rankings.

After George Washington, Harry S Truman is probably the U.S. President most widely known to have been a member of the Craft. He was active in the Fraternity from his raising in 1909 until his death in 1972 (the only one of our fourteen to reach that 50+ year mark), and his involvement was an important part of his life. One of only two of our fourteen to serve as

Grand Master, Truman presided over the $M \cdot W \cdot G$ rand Lodge of Missouri, A.F. & A.M. in 1940-41, while serving in the U.S. Senate. Although he was most involved in Blue Lodge Masonry, Brother Harry was also a York Rite and a Scottish Rite Mason, coroneted a 33° (Honorary) in 1945. Although a Scottish Rite Mason in our Mother Jurisdiction, Ill. Bro. Harry is also the recipient of the NMJ's Gorgas Medal: their highest honor.

M: W: and III. Bro. Harry's ranking in this survey has probably changed more, over the years, than any other former President, and that is probably because he occupied the Oval Office when the rankings were first done. Historians have certainly come to think more and more highly of "The Man from Independence" as the decades have gone by. He was seen as mostly a "faint shadow" of FDR, when he assumed the office (the press even referred to him—as they had John Tyler, in the 19th century—as "His Accidency"... which Brother Harry found hilarious), but his judgment and policies have stood up well to the brutal assessment of history, with his ranking rising steadily on succeeding iterations of the survey.

No man ever came to occupy the White House under stranger circumstances than Brother Gerald Ford. After a distinguished and successful career in the U.S. House of Representatives (which was likely a major reason for his being coroneted an Honorary 33° in the NMJ in 1962), he watched as President Richard Nixon's second term (commencing in January 1973) rapidly became a game of "musical chairs." V.P. Spiro Agnew and then the President himself were forced to resign by personal and political scandals, so that Brother Ford became the first une-lected person to occupy first the Vice Presidency and then, just eight months later, the Oval Office itself, under the provisions of the 25th Amendment. [A primo political trivia question, BTW, is "Whom did President Ford then nominate to fill the vacancy in the VP position?" or "Who was Ford's Vice President?"]

Brother Jerry served at a triply difficult time in the nation's history. Not only was the nation deeply divided by the circumstances that led to Nixon's departure, but we were in the throes of a controversial withdrawal from an unpopular war in SE Asia. To top off already frustrating circumstances, the American economy was faced with the double whammy of high unemployment and ruinous inflation (remember "stagflation?"), which government action couldn't seem to turn around. On that latter issue alone, Ill. Bro. Jerry earned especially low marks, with an effort to "jawbone" a remedy for our economic woes. "Whip Inflation Now!" was a project to encourage lower consumption & higher savings rates: a campaign later described as "one of the biggest government public relations blunders ever."

In an effort to put scandals and controversy in the nation's rear-view mirror, President Ford granted former President Nixon a "full and unconditional pardon," in September 1974. That decision probably sealed his electoral fate when he decided to run for election in 1976. Many voters saw the pardon as a corrupt "deal" struck between the two, although commentators now tend to agree that it was more an effort to "move on," after a distasteful period in our political history. Personally (and, yes, to some degree, setting policy disasters aside), I give Jerry Ford high marks for his dedication and patriotic response to the challenge of stepping up to accept the mantle of leadership, under difficult & unprecedented circumstances. Objectively, he may deserve the low ranking, but his willingness to take up the reins, with little regard for his own interests, is (again, IMHO) an example of dedicated and selfless service.

James Monroe was the last of the "Founding Fathers" to serve as President and the last of the "Virginia Dynasty" to dominate the early presidency. He was a junior officer, under George Washington's command, early in the Revolution, interrupting his education to serve. He rose to the rank of Major (and Colonel of militia) during the war. Brother Monroe had a successful career as an attorney, legislator, and diplomat, before his election to the presidency in 1816. He was reelected in 1820, almost without opposition, with only a single electoral vote cast against him ... and that because one elector believed that only the great Washington should have the honor of a unanimous election!

Bro. Monroe is ranked as an "above average" President. During his tenure, the Missouri Compromise averted a national crisis over slavery, Florida was purchased from Spain, and the proclamation of the Monroe Doctrine put European powers on notice that the Americas were off limits to new colonial expansion. One tidbit of Masonic interest is that, while President, he visited Cumberland Lodge No. 8, in Nashville, Tennessee, and was extended the honor of a private reception by the Lodge. He was greeted by Worshipful Master Wilkins Tannehill, who later served several terms as Grand Master of Tennessee ... one of those as the predecessor of Bro. Andrew Jackson in that office!

William McKinley was serving in the Union Army, during the Civil War, when he noticed a fellow Union officer (a physician) handing out cash to Confederate prisoners-of-war. He confronted the doctor and was told that the prisoners were Freemasons, in financial need, and that the doctor (likewise a Mason) dispensed charity to them with the understanding that they would repay or reciprocate in helping others as they were able. McKinley resolved, then and there, to join the Fraternity: amazed at the dedication to principle he saw in that act. He was so impressed, in fact, that he petitioned and joined a Lodge in Virginia immediately upon the surrender of Lee's army at Appomattox: not even waiting for a return to his home in Ohio to follow through on his desire. He remained active in the Craft during the remainder of his life.

McKinley was a successful Chief Executive. He defeated the formidable William Jennings Bryan ("The Great Commoner") in both the 1896 and 1900 elections and led the nation during the Spanish-American War. That brief conflict placed far-flung territories (Cuba, Puerto Rico, Guam, the Philippines) under U.S. control and heralded the arrival of America on the world stage ... events which portended the actions of his successor and fellow Mason, Theodore Roosevelt (who assumed the office when McKinley was assassinated in 1901).

It is difficult to even assess the job that James Garfield did (or might have done) as President, since he served for only about 200 days (the 2nd shortest presidential tenure). Inauguration was on March 4, and on July 2 he was shot, while *en route* to a college reunion. He died on September 19, 1881. A top priority of his brief presidency was a push for civil service reform, and, in his divided Republican Party, that was motivation for a deranged member of the opposition faction to take his life. Ironically his successor, Chester Arthur (a supporter of that rival faction), followed through with many of Garfield's intended programs.

Although details of his Masonic career are sketchy (at least in readily available sources), it is, I believe, safe to say that Bro. Garfield had a considerable commitment to the Lodge. During his tenure as a Representative in the U.S. House (1863-81), he participated in the formation

of a new Lodge in the Washington, DC area (his home Lodge being back in Ohio) and was a charter member of that Lodge. The <u>James A. Garfield National Historic Site</u>, in Mentor, Ohio, is worth a visit, if you find yourself in the Cleveland area.

Brethren, my intended "two-parter" is running long, with three worthy Brethren (and some comments about them all, from a Masonic perspective) still to cover. So, I'll call it a wrap for this month and continue and conclude in May.

Last Month's Trivia Question: What is the difference between a Masonic Festive Board and a Table Lodge?

Answer: [Congratulations to Brother Juan Carlos Millan, for providing the essence of a correct answer, last month & on the day *RiteWorks* was posted.] There are several ways to explain the difference, as well as occasional confusion in doing so. The simplest answer is that a Table Lodge is a tiled meeting, and a Festive Board is not (being, rather, a more formal version of our usual meals...a "banquet," if you will. That being the essence of the difference, there's much more to be said by way of a complete answer: especially for anyone who isn't particularly familiar with either tradition of the Craft.

For those with a background in military service, there's something of a parallel in the traditions of formal military dining events referred to as a "dining in" or a "dining out." The former with attendance limited to members of a particular service unit, versus a "dining out," at which guests may be invited and included in the festivities.

A Table Lodge is a meeting of a chartered Lodge, in most every detail. The Great & Lesser Lights, as well as the Charter, are displayed, officers' stations & places are assigned around the table, and an opening & closing ritual is followed. Again, the meeting is tiled, so the tradition of having the ladies or members of Masonic youth groups involved in preparing or serving the meal is not possible, unlike at a Festive Board. In most jurisdictions, a Table Lodge must be held in the location and at the time of a Lodge's stated communications, although, of course, Grand Lodges can & do grant dispensations for other arrangements.

Both events traditionally include a ceremony of toasting, generally with wine, and there's again some carry-over from the military events in the rather arcane formality & terminology used in that process. In Colorado, the presence of "adult beverages" (always, BTW, with a strict admonition not to overindulge) results in the Grand Lodge ritual for the Table Lodge specifying that neither degree work nor formal Lodge business (e.g., financials) may be conducted.

Another similarity lies in the tradition of featuring a guest speaker for an after-dinner presentation. In fact, in many jurisdictions, the formal name of the tiled event is "Table Lodge **of Instruction**," and the standards are often very high to make the evening an educational event.

Rituals for both events may be obtained from the Grand Lecturer, or I'll send them to you upon request. Please understand that I cannot guarantee that I possess the most up to date version of either document.




