# PASSWORD SECURITY

Everyone has a password. Most of us have MANY passwords. Unfortunately, passwords are a part of your digital life anymore, and every time you visit a new website or download a new application, they want you to create a new password. Some folks get a bit lazy and reuse the same password over and over again because it's easy to remember. Some folks use very weak passwords—again, because they're easier to remember. The problem with re-use and simple passwords is that a hacker can break simple passwords relatively easily, and if you re-use it, it opens up a lot of your personal (financial, medical, professional) information to someone [3277597] who might not have your best interests in mind.

Here's the problem, if you're like me, you have probably a hundred or more applications, accounts, and places you visit that require a password. There is NO WAY you will ever be able to remember hundreds of passwords, especially since most of these places use different rules for the password you must use. Government agencies are the worst—usually mandating 12 or more characters, a mix of upper/lower case, numerals, and only certain specific special characters—AND... you must change them every 120-150 days. Oh, they're really nice in that they "remind" you that your password is expiring and you need to change it, but they also tell you that there are certain rules about how much of the old password you can re-use before they reject your new one. And, in the case of government, they might also tell you that you can't re-use any of the last 10 or more passwords. Joy.

So, how do you deal with this particular conundrum? Well, there are actually a couple of easy and secure ways, and one very Unsecure way. First, the unsecure way: let your computer remember them in your browser or have them reside in a text file. But, how can you safely protect your passwords and at the same time make it convenient for you to login to these various sites that require them? Well, there are what is called "password lockers" where you have an encrypted program on your computer that stores these passwords, but you have to remember a MASTER Password to access them. That's OK, unless you forget your Master Password, and then you are hosed. Another way is to have a "little black book" that you log all your passwords in, hopefully in some logical order so you can actually find the password you need in a hurry. Of course, you could also create a computer file on a system NOT connected to the internet, and keep it there. This is called a "sneaker net" computer in that you must have a second computer that is NOT connected to the internet world available at all

to be ABSOLUTELY sure that no one from the outside can get to your information. A Pain? Surely. The other thing to be somewhat concerned about is cryptographic security of the application you do use to protect your passwords. You don't know what algorithm they're using, so you can't know how "safe" it is from hacker attacks. [5097456] Just think about this: what used to be considered a "super computer" just a few years ago is now available on your phone! The Apollo missions to the moon only had 64k of RAM computer memory and were programmed in hexadecimal code from a keypad, not a typewriter keyboard.

# A Point of Pride Revisited, Part III

Finally, we come to the last installment of a look at the fourteen Masons who have served the nation as President. Last month, we made it through to the "middle three" on our list, having chipped away from both ends of rankings [9592924] from the 2021 version of a <u>Presidential Historians Survey</u>. Our journey now brings us to one 20<sup>th</sup> and two 19th<sup>th</sup> century Brothers and then, to conclude, back to a look at all fourteen.

We're ready now to consider three lesser-known Chief Executives, one of whom is among the most iconic (and controversial) of the 19<sup>th</sup> century.

James Knox Polk rarely rates mention on anyone's list of great Presidents, and yet he was, without doubt, one of the most thoroughly successful to serve during America's formative decades. He has the unusual distinction of achieving virtually all the objectives put forth in his 1844 campaign: presiding over banking and tariff reforms and territorial expansion that increased the nation's size by a third! With the annexation of Mexican territory (following the 1845 war with that country), Texas, Oregon Territory (resulting from successful negotiation with Britain), and California, Polk saw the U.S. assume the continental boundaries it has today, save only a strip of Mexican territory later purchased to provide a railroad right-of-way.

As President, Polk oversaw the opening of the U.S. Naval Academy and the Smithsonian Institution (participating in a Masonic cornerstone ceremony for the latter), groundbreaking for the Washington Monument, and issuance of the first postage stamps in the United States. He was a Tennessee Mason (Columbia #31) and a Companion of the Royal Arch. As a protégé of Andrew Jackson, he was both fondly and pejoratively referred to as "Young Hickory."

Andrew Jackson was probably the only 19<sup>th</sup> century occupant of the White House, save Lincoln, to rival the Founding Fathers for historical standing. A North Carolinian by birth, he made his name and fortune on the frontier: born before the Revolution (1767) and in that first great surge of "pilgrims" to flock to the West after Independence. Jackson's early political career—typical of his reputation and personality—was a veritable whirlwind, as he held office as a U.S. Representative, U.S. Senator, and Judge of the Tennessee Supreme Court (he began

practicing law at the age of 20!) ... all between 1796 and 1804! He also managed to gain a commission as a Major General in the Tennessee Militia during that time. His reputation as an Indian fighter garnered him that same rank in the U.S. Army in 1814, when he was sent in command of forces to successfully defend New Orleans, during the War of 1812.

His record as President is one of both change and controversy. Jackson was a dedicated advocate of expansion of the nation to new western territory ("Manifest Destiny"). Although the U.S. acquired no new territory during his administration (1829-1837), Jackson presided over a period of energetic settlement of the areas added earlier. A cornerstone of that policy was the removal of native peoples from their traditional homes to western territories. In Jackson's case, the often-brutal pursuit of that policy even led him to defy an order of the U.S. Supreme Court to achieve the goal. Politically, he also supported a shift of political power from Eastern elites to a more rural and Western electorate. He promoted his own image as a champion of the common man ... whether or not that was an entirely accurate perception.

For our purposes here, the height of Andrew Jackson's political career came at a somewhat unusual time. Between his first (unsuccessful) run for the presidency, in 1824, and his triumphs in 1828 and 1832, the Anti-Masonic political movement (in the aftermath of the Morgan Affair) rose to the height of its influence in the nation's public affairs. The appeal of Jackson, as a military hero and western populist, propelled him past strong sentiments against the Fraternity: a feat that lesser men did not achieve.

Jackson's Masonic record is interesting ... and somewhat difficult to pin down. Several Lodges claim him as a member. The record of his degree work is disputed as to time and place, although his actual membership is not. There is no record of his having served as Master of any Lodge, even though the Grand Lodge of Tennessee elected him Grand Master in both 1822 and 1823! He was also a Companion of the Royal Arch, but, likewise, there is no record of his membership in a chartered Chapter! Masonic historians generally agree that his standing there was likely the result of the degree's conferral in a Craft Lodge: a common practice in that day, as it still is in England. Personally, I suspect that firm dates of his Masonic achievements may well have fallen victim to the lost records that were a not unusual result of Lodges' efforts to maintain a "low profile" during the Anti-Masonic era.

Finally, we come to the last of our Masonic Fourteen, with a look at Brother William Howard Taft. Between 1877 and 1923, six Ohio men—four of them Masons—occupied the White House for 18+ years, serving all or part of seven presidential terms. And you can make that seven, 26+ years and nine terms, if you include U.S. Grant, who was born and raised in Ohio but elected from Illinois!

Brother Taft has the distinction of having been made a Mason "at sight," on February 18, 1909, within the Body of Kilwinning Lodge No. 356 in Cincinnati, by Grand Master Charles S. Hoskinson. His father and two brothers were also Members of that Lodge, and he commented on the occasion, "I am glad to be here, and to be a Mason. It does me good to feel the thrill that comes from recognizing on all hands the Fatherhood of God and the Brotherhood of Man."

Masonic achievements are difficult to pin down for Brother Taft, but one of his favorite public policy causes was government support for health-related institutions and services. This in-

terest rather foreshadows our modern Masonic commitment to many and varied (and especially children's) health issues, although, of course, our involvement is in the private sector.

Taft was more-or-less "hand-picked" to succeed Brother Theodore Roosevelt, in 1908, when TR chose not to seek another term. Teddy, however, spent much of the next four years nitpicking Taft's actions and policies, choosing to form a competing "third party" to run against him in 1912. That decision doomed Brother Taft's re-election bid, handing the White House to Woodrow Wilson. Electoral defeat did not, however, end Taft's career as a public servant. In 1921, he was nominated (by Brother Warren Harding) and confirmed as Chief Justice of the U.S. Supreme Court: his life-long ambition. [6993059] He served in that position until just before his death in 1931: authoring over 250 opinions, overseeing a thorough overhaul of the High Court's procedures and administration, and planning the construction of the court's new (and present) home, just across First Street from the U.S. Capitol. He is the only person to have headed two branches of the federal government.

### As Masons...? As men...?

So, what sort of men and Masons were these fourteen individuals, whom we cite as examples of the standing of our Fraternity? It probably comes as no surprise to discover, in terms of their activity and commitment to the Craft, that they were more-or-less as we are. Some were dedicated to their Masonic involvement and sought out opportunities to serve and promote its purposes. Some commented freely about their affiliation. Some came to the Fraternity early in their lives...others late. Some expected little from their involvement and received much. As an example, Harry Truman commented, even while serving as President, that he considered his title of PGM of Missouri the greatest honor of his life! Some (I conclude, finding little evidence of their interest in the Craft) carried dues cards and little more.

I found no evidence that any of the fourteen ever had any "second thoughts" about their Masonic affiliation, but I did discover an indication that a Lodge nearly balked at receiving one as a member! Warren Harding was initiated in 1901, but objections raised in Marion Lodge #70 (Ohio) delayed his advancement until they were rescinded in 1920...when he was running for President. Interesting timing!

Were they "good men and true?" Once again, I find them to have been much as we are. They all seem to have been of "good report" in their communities...some certainly "more so than others." Men in positions of power and influence have (and, unfortunately, do still) "get a pass," all too frequently, on moral or ethical issues, and this was no less the case for a few of these Brethren. At least one struggled with sobriety ...some with anger management ...some with doing undue political favors for friends (who sometimes proved unworthy of them) ... several with temptations to stray from marital fidelity. On that latter front, at least one regularly surrendered with little evidence of "struggle" at all, while another died during a conversation with his long-time mistress! I'll let you do the research on those yourself!

As I look at the results of my own study, I conclude that all these men were unquestionably dedicated to their country's best interests, as they understood them to be. That latter phrasing is a necessary caveat, as I happen to believe that we generally err when we hold "the past" responsible for living up to the standards of "the present." Several of our "Masonic Fourteen" were amazingly able public servants and almost astonishingly resolute decision-makers. These

made decisions which, had their judgment been seriously flawed, would have made our nation a very different place today. I would also suggest—and it's my own opinion ... you may do your own study—that one of them also made some policy decisions that have not turned out well at all!

I would make two final comments: one about the whole idea of presidential greatness and one, specifically, about several of our Masonic Fourteen. When we look at the concept of greatness in office, one of the things we must remember is that the 19<sup>th</sup> century was a period dominated by congressional power. Many of the political "greats" of that era were congressional leaders (Clay, Calhoun, Douglas, Blaine ...). So, it's no surprise that only two of the topten in the larger survey (Jefferson & Lincoln) were 19<sup>th</sup> century Presidents. That's two administrations (just over 12 years) over a full 41% of the nation's history! Both of those men distinguished themselves with actions and policies which largely transcended congressional control. Bluntly, If the times (for whatever reason) do not call (or allow) for greatness, it is a rarely displayed quality!

Finally, regarding our Masonic Presidents, I admit that I do wrestle with what to say about the four (Washington, Monroe, Jackson and Polk) who were slave-owners. I am still somewhat of two minds on what opinion to hold of them, and I hope you'll indulge an explanation ... at which point I invite you to draw your own conclusion. History has, at least until recently, tended to give "a pass" on the issue: "those were different times, after all," it is said, and perhaps that is the proper attitude. However, if we choose to study all the history of "those times," we must deal with harder issues: hence my dilemma. On the one hand, I stand by my preference to have history written "in the light of the times" ... and those were, yes, "different times." That point-of-view makes me an opponent of "cancel culture" and its effort to rewrite the past. I might not totally "give them a pass," but I would recognize that the issue is not the same today as it was then.

On the other hand, I know (as does any student of Masonic history) that our Order originated in the ideas of The Enlightenment, and that origin is central to what leads us to celebrate our role in America's founding. My dilemma then is that there is no concept so fundamental to Enlightenment thinking as human beings' absolute, inalienable right to liberty! I suggest to you that there is a difficulty in accepting this concept (and expressing pride in what it has meant in the history and philosophy of the Craft) while excusing fundamentally contrary behavior by members of the Fraternity!

You see my dilemma, I hope, and I invite you to wrestle through to your own conclusions ... and share them, if you wish.

So, our fourteen Masonic Presidents were, in the final analysis, not so very different from their thirty presidential peers nor so very different from all of us. When you think about it, isn't that really the whole point of popularly elected government: the idea that common people—good-intentioned though flawed as they are—can run their own affairs and govern a great nation?

**Last Month's Trivia Question:** In what jurisdictions are the Scottish Rite's Craft Degrees (EA°, FC° and MM°) commonly worked?

**Answer:** It sometimes surprises Scottish Rite Masons to discover that there are Scottish Rite Craft degrees! As I've noted in this space before, however, the Scottish Rite, as its predecessor developed in France in the 18<sup>th</sup> century, was a complete Masonic "system," and so would, of course, have taken a candidate through an initiatory experience "from square one." It is the preexistence of Grand Lodge jurisdictions in the United States, at the time the Rite arrived here, which caused that complete system to be truncated to become our current offering of twenty-nine degrees. For the rest of the story, I turn to a narrative from our own Scottish Rite Research Society (SRRS):

In 1804, French Masons created a Craft (Blue Lodge) ritual for the Scottish Rite. Although versions of the ritual are used in very few Grand Lodges in the United States, they are popularly conferred in Garibaldi Lodge No. 542 in New York City, in several lodges in the 16th District of New Orleans, Louisiana, and a few other states. [2716892] Versions of the Scottish Rite's Blue Lodge ritual are, in fact, conferred in more countries than any other form of Craft ritual. These rituals include more symbolism than the Webb-form rituals, commonly used in the United States, and are much more dramatic in nature.

In 1870, Albert Pike authored and caused to be printed a version of the Scottish Rite Blue Lodge ritual, which he intended as a foundation for the rituals of the Southern Jurisdiction. He noted that the Webb-form did not provide the continuity necessary to fully appreciate the mythology and lessons of the Scottish Rite. To supplement the work, a "Liturgy" (monitor) of these Degrees was also printed. Very few copies of these works survive.<sup>1</sup>

So, when we tell new Scottish Rite Masons that our "completion" of the story of the 3<sup>rd</sup> Degree, in the Lodge of Perfection, takes us over a different road and involves details not included in the Blue Lodge portrayal of the MM°, this is the reason for that difference!

You may ask, "How can I learn more about these degrees?" If you're at least a year-long member of the SRRS, you recently received a copy of Albert Pike's *The Porch and the Middle Chamber*, in a new edition prepared by Arturo de Hoyos, 33°, GC. This 886-page work is a compilation of that "few copies survive" work! If you're not an SRRS member, but join now, a limited number of the books are available from the Society, at a cost of \$70 each. Remaining copies may eventually become available from the Scottish Rite's online store, but it was a very limited run, and there may not be many (if any) copies left.

This month's Trivia Question (answer in next month's *Rite Works*): Our distinguished Brother and First President George Washington was born on February 11, 1732. Why then do we celebrate the anniversary of his birth on February 22?




